The County Planning Board has reviewed the site plan and has made some recommendations, which were not in applicant's power to change such as the egresses in and out of the site plan. A public hearing is required for site plan approval.

Councilman Artist inquired if the site plan has adequate storm water drainage, detention ponds and treatment for storm water run off.

Mr. Shuster stated that a specialist is studying the site plan and will offer his recommendation.

Farm to Market Road is not an ideal intersection. Councilman Van Kleeck suggested reviewing the roadway. Mr. Shuster explained that many of the road problems could only be resolved through the State level.

Grace Community Church vacant lot (Site Plan): 850-860 Neighborhood Road & Seremma Ct. (Lake Katrine)

Mr. Shuster explained that the church wants to place a new facility on Neighborhood Road. The site is surrounded by wetlands. They propose placing three buildings on the higher areas of the site. This project only requires site plan approval. The Town Planning board recommends approval.
