Councilman David Brink reported that he had some discussion on sign ordinances and plans to talk to the Town Planner. There are some zoning law changes that he would like to recommend to help remove some anomallies. He would like the town to have a grading law to prevent people from changing their property before they apply for a building permit. He suggested the Town Planning Board handle all the applications and remove the Town Board from the procedure process to prevent an extra month. Another problem that arises is that the Town Planning Board is the lead agency, but the Town Board has the final say so they should be lead agency. He would like to hire a planner to work just on these changes and to help out with the comprehensive committee. He also suggested that the Town should have written standards for curb cuts. He also is looking into silent railroad crossings. He stated that they have a horn that is directed at the highway so the sound would not be that great. It is expensive.

Councilman Joel Brink reported that the brush at the Town Transfer Station was overflowing and suggested that the Town hire someone to grind it. He would like to address that at next meeting.

Supervisor Woerner reported that there will be a vacancy among the parks attendants and that he would like to fill that at the next meeting.

John Morrow, Chairman of the Comprehensive Committee, reported that they had some public meetings looking for input, explaining what they are doing. They are looking at open space, agriculture, and commercial growth. He felt that the proposed Conservation Committee was a duplication of service and asked to consider incorporating them into their committee. All these funds are available to the town and the town just needs to apply for them.
