### **Public Comment**

Mr. Robert Crane recommended that retirement benefits for Medicare reimbursements be eliminated and Health benefits for part-time elected officials be eliminated.

Mr. Rocco Secreto inquired if each council member agrees with the \$1,000 increase and how much time the members put in. He was not in favor of the Town Board members receiving health benefits.

Mr. Robert Barton was not in favor of the elected officials' raises. He feels that all the raises should be based on merit.

Supervisor Quigley reported that the town can't move to a performance based system due to labor contracts. He felt that the elected officials' raises were not out of sync with what the employees were receiving.

Councilwomen Hendrick offered the following suggestions:

Reduce the payroll increases for elected officials in 2014 to 0% and give the remaining balance in 2015 once safety net is no longer in the budget. This will free up around 200K available for new expenditures.

No pay increases greater than 10%.

Part time elected officials pay the difference from single to family for health insurance.

Remove payroll clerk \$12400 (Compensation is already paid for this position)

All appointed positions receive the same increase as union employees.

Remove Town Attorney and Town Planner from workshop meetings.

Harboring and euthanasia reduce to \$10K.

Change phone system to VOIP and save \$2500 per month or more (buy new phones next year with savings from safety net)

New hire for 2014 of Municipal Code officer reduce to \$40K.

Reduce assessor part-time clerk wage to \$10K.

A discussion followed after the suggestions.

Mr. Robert Crane suggested that the Town tax the budget to the full 2% and use the difference to build the town's reserves.

Councilman Morrow moved to close the budget hearing at 7:38 PM 2<sup>nd</sup> by Councilwoman Hendrick
