Department Head Reports

Water Dept. – John Rose stated that everything is going well across all water districts, with repairs being made where necessary, when necessary. There was a break in East Kingston, that was the 3rd break this year. Hydrant Flushing will be done during the month of October and this information is posted on the Town Website.

Wastewater Dept. – Corey Halwick stated that the Sewer Districts are all performing satisfactorily. The work on the Primary Water Clarifier in the Whittier Sewer District is progressing. Site Plans are being reviewed for Ulster Commons.

Recreation Dept. – Jeff Hayner stated Adult Softball has finished, and we have completed our first year of Beach Volleyball season nicely. Boat Permit sales at Rider Park have concluded, as has Summer Camp. Mr. Hayner was happy to report that camp finished up \$10,000 under budget. Adult Volleyball is starting up, and sign-ups are under way for Biddy Basketball. There will be sign-ups at Town Hall on Friday evenings from 6-8 pm. Post Park hours have changed and the park now closes at 7 pm. Football practice is still ongoing.

Highway Dept. – Frank Petramale stated that everything is going well and they have been very busy. There have been several new drainage projects completed, roads have been patched, swept and some paving will be done over the next few weeks. The parking area at the Rail Trail has been completed, a septic has been installed at the park, and mowing is being done. Leaf pick up has been scheduled and posted on the Town website, with the printed version available at the Town Clerk's Office.

Police Dept. – Lieutenant Gramoglia stated that the day to day is going well with nothing major to report. Lt. reported the total calls with a breakdown of different types. They are doing a car seat inspection/installation this weekend at Ulster Hose on Albany Avenue. They will also be at the Adams Harvest Fest on October 12th.

Assessor's Office – James Maloney stated that the 2015 Final Roll was filed on July 1st as required by law. His office is in the process of starting the preparation of the 2016 Roll. Within the next 30 days all exemption renewal applications will be mailed to the Seniors and other property owners that qualify for exemptions.

Town Clerk's Office – Linda McDonough reported a successful Town of Ulster Senior Picnic. Music and Food were enjoyed by all on a sunny day at Post Park. There were 172 residents and 15 non-residents attending. Outlined were the totals of fees collected for the period of May 1st to August 31st, the new procedures of water and sewer rent collections that was implemented on May 4th, and the completion and reconciliations with Ulster County for the Tax Collection period ending on June 1st. In addition, there was the hiring of the additional Clerk, filling the position that has been vacant for several months. Ms. McDonough also advised the Town Board that she has passed the Notary Exam and was awaiting her supplies. The Office continues to work with Department Heads on various updating of procedures to streamline processes for both the residents and the town.

Supervisor Quigley requested for discretion to take one item out of order:

WHEREAS, pursuant to Section 161-9 of the Town Code, the Town Board has the authority to approve the Site Plan application, upon a favorable recommendation from the Town of Ulster Planning Board, since more than 2,500 SF of new gross floor area is proposed with this application; and

WHEREAS, the Town of Ulster Planning Board, at its September 15, 2015 meeting referred this matter to the Town of Ulster Town Board with a recommendation to grant Conditional Site Plan Amendment approval; and

WHEREAS, the Town Board as Lead Agency upon review of the SEQR Short EAF Part 1 determined the Proposed Action was an *Unlisted Action* pursuant to 6NYCRR Part 617 of State Environmental Quality Review (SEQR) Law; and

WHEREAS, the Proposed Action was referred to the Ulster County Planning Board by the Town of Ulster Planning Board pursuant to Section 239 1 and m of NYS General Municipal Law and written comments from the UCPB were received that included *required modifications*; and

WHEREAS, upon review of the UCPB required modifications, the Town of Ulster Planning Board found two of the required modifications were satisfied through revisions to the applicant's plan set and the remaining one would be satisfied by requiring the applicant to sign an agreement to participate in a stormwater improvement district when such district is formed; and

WHEREAS, the Town Board, upon review of supporting application materials and subsequent completion of the SEQR Short EAF Part 2 determined the Proposed Action was one that would not have a significant adverse impact on the environment made a SEQR Determination of non-significance.

NOW THEREFORE BE IT RESOLVED, the Town of Ulster Town Board has determined the Town has complied fully with the procedural requirements of Part 617 of the State Environmental Quality Review (SEQR) Law and herby issues a Negative Declaration on the Proposed Action; and

FURTHER BE IT RESOLVED the Town of Ulster Town Board grants Conditional Site Plan approval for the Proposed Action on the above referenced site subject to the conditions, limitations and restrictions set forth below.

- 1. Compliance with applicable zoning and building laws, rules and regulations;
- 2. Compliance with all representations made by the applicant;
- 3. Compliance with site plan, design plans and all details as cited herein;
- 4. Approval is granted to allow the limited striping of the site at this time, subject to the owner agreeing to provide additional spaces within three (3) months notice of the Building Department of the need for more spaces.
- 5. The applicant consents to signing an agreement to participate in a stormwater improvement district when one is created for the area surrounding the subject site and the deposit of \$10,000 with the Town of Ulster towards the creation of the stormwater district.
- 6. The Town's consulting planner and Building Inspector are hereby authorized to approve minor Site Plan changes of a ministerial nature, which may arise due to unforeseen circumstances in the project site development; and
- 7. All fees, including consultant fees, shall be paid.

Frank Rittie Jr, 113 Railroad Ave, E. Kingston – presented a petition with 144 signatures requesting that all Ulster Town Board Members vote against the passage of the animal husbandry law as it appears on the Town website. The proposed law infringes on our right to be self-sufficient and removes a characteristic of our neighborhoods that has been a part of our lives for generations.

He showed on the map that the R-10 and R-30 in East Kingston are the least populated area of the Town and conflicts with previous statements. He also stated that at all meetings there has been maybe one person that is in favor of this law. In addition, he asked that the Town Board review the DVD he previously supplied to them which shows the characteristics of the people who are asking for this law to be passed.

The Petition with signatures was turned over to the Town Clerk.

Robert Sweeney, 1019 Flatbush Rd, Town of Ulster – Mr. Sweeney is also the Town Historian and brought six of his chickens with him. Mr. Sweeney stated that this proposed law makes recommendations, which cannot be done. It has to state what you can have, or cannot have. He believes this law to be biased against chickens. He also believes that there are items of this law that cannot be enforced. Nuisances should be addressed, not a list of things not allowed. Dialogue should be encouraged by an agricultural committee to adjudicate these issues.

If you can have 5 sheep on an acre, then it makes no sense that you can only have one-sexed poultry. He believes this law is discriminatory and will lead to more discrimination.

Melanie Martucci – 72 Wildwood Lane, Saugerties – She is an R-30 residence and called to find out any laws that applied before getting her chickens, and there were none. Her chickens are her pets, and are no different than cats and dogs. There are many other things (cars, 4-wheelers etc.) that make more noise than her chickens or any roosters' people own.

Krista Montforte – 17 Corwin Place, Town of Ulster – would like to reiterate what everyone has said. She also advised that she was told she would be grandfathered in, and would like a letter from the Town stating same. She doesn't believe she should have to be grandfathered in, and again stated that she has never had a complaint from her neighbors except for when she installed a fence limiting view of the chickens. She also stated that she has 30 chickens, and she only gets 2 eggs a week right now. Also there is a minimum order when you order chicks and

laws govern other aspects of what you can do when you order chicks. Again, there are a lot noisier things out there.

Cecil Towns, 965 Flatbush Rd, Town of Ulster – as a taxpayer, a Former Marine and an American, people should be able to have what they want on their property. Neighbors should be able to talk to each other regarding neighborhood problems. This is America-Leave it alone.

William Smith – 601 Lenox Place, Town of Ulster – He has a residence with horses, and he wants to know what constitutes and acre and where does the limit start and end. If he is grandfathered in, and one of his horses leaves, is he able to get a replacement on the grandfather law. Again, neighbors should talk to each other and make things work.

Tom Cole, 169 Railroad Ave, East Kingston would like to know if there is anyone for this law?

He also wanted the residents to know that October 2nd is Wounded Warrior Weekend. They leave Rhinebeck at 4:45.

Robert Sweeney 1019 Flatbush Rd., Town of Ulster stated he is not against the law, he just has a list of concerns about what is allowed. The law needs to state the lot size or paddock size and what can be on that size. The law is not clear and it should be voted down. He will supply the list to the Supervisors office

Supervisor Quigley stated that all comments would be taken into consideration as the law is considered and the public will be kept informed.

Resolution Authorizing Interfund Loan from the Landfill Closure Reserve Fund to the Whittier Sewer District in the amount up to \$200,000 Plus Accrued interest

WHEREAS on August 9, 1988, pursuant to Section 6-f of the General Municipal Law as amended, the Town Board of the Town of Ulster did establish a Capital Reserve Fund known as the "LANDFILL CLOSURE RESERVE FUND" to finance the closing of the Town's landfill, and,

WHEREAS monies have been deposited in a bank account known as the Landfill Closure Reserve Fund, and

WHEREAS the Supervisor was authorized to invest from time to time the monies of said fund pursuant to Section 6-f of the General Municipal Law on authorization of the board pursuant to Section 6-c of the General Municipal Law, and,

WHEREAS the Town of Ulster, by deed dated May 18, 1993 conveyed the Town Landfill to the Ulster County Resource Recovery Agency which has assumed responsibility for costs of closing and capping the Town Landfill and,

WHEREAS the money deposited in the Landfill Closure Reserve Fund is no longer needed for this purpose and may be transferred to another account pursuant to the authority vested in the Town Board by General Municipal Law Section 6-c (9-a), and

WHEREAS it is proposed to loan monies from the Landfill Closure Reserve Fund to the Whittier Sewer District (hereinafter the "District") to cover the balance of expenses for the Primary Treatment Replacement Contract; and

WHEREAS, such loan from the Landfill Closure Reserve Fund to the Glenerie Water District will save the Whittier Sewer District the cost and expense of borrowing the needed funds, and

WHEREAS, given these circumstances, the District has requested that the Town Board authorize an interfund loan in order to advance the costs of the Primary Treatment Replacement Contract for the Whittier Sewer District from the Landfill Closure Reserve Fund to the District's Fund, until such time that the District can collect such taxes or otherwise generate sufficient revenue; and

WHEREAS, pursuant to General Municipal Law § 9-a, all interfund loans must be authorized by Town Board resolution, now therefore be it

RESOLVED, that the Town Board of the Town of Ulster hereby authorizes an interfund loan of up to \$200,000.00 from the Landfill Closure Reserve Fund to the Whittier Sewer District; and be it further

RESOLVED, that, pursuant to General Municipal Law § 9-a, said monies shall be repaid to the Landfill Closure Reserve Fund no later than December 31, 2016; and be it further

RESOLVED, that the interest rate established for the borrowing period is 1.0% per annum, and the repayment obligation amount is up to \$200,000.00, plus accrued interest; and be it further

RESOLVED, that the source of funding shall be a Landfill Closure Reserve Fund Interfund loan, in the amount of up to \$200,000.00, to the Whittier Sewer District and be it further

RESOLVED, that the Town Supervisor is hereby authorized to take any and all steps necessary to effectuate said loan.
