The applicant is requesting site plan and special use permit approval to construct an approximate 4.1 MW-AC community solar photovoltaic array on the lands of DSC Sisters, Inc.. The site has frontage on Tuytenbridge Road and Carle Terrace, and proposes to gain access from Tuytenbridge Road. The site is located within the Region Commercial, R-10 Residential, and R-60 Residential districts.

Submission/Procedure

1. Use Designation. The application is for a site plan review and special use permit, but the designated use of the site is unclear as it relates to applicable supplemental regulations to be reviewed by the Planning Board. Clarification is needed regarding if an official determination has been issued.
2. Town Board/Planning Board coordination. We note that per §190-43: "The Town Board may set a public hearing for a special use permit upon receipt of the report and recommendation of the Planning Board." A public hearing was held by the Town Board on this application on January 16, 2025, and closed that day. Was a report and recommendation provided by the Planning Board prior to the public hearing? We suggest that the Town Board discuss extending the approval timelines per §190-43 with the applicant as the Planning Board has not had sufficient information with which to perform a detailed site plan review.
3. Given the steep topography and significant clearing proposed for the site, the Town and/or Planning Board Engineer should review and comment on proposed stormwater management, and erosion and sediment control measures. A SWPPP is required and does not appear to be provided in the submission materials this office received.
4. Due to the recent nature of our appointment as consultants to the Board, additional information is needed regarding the status of this application. Additional comments may be issued in subsequent memorandums.

Zoning

1. The site is located within multiple zoning districts, which should be clearly shown on the site plan.
2. Zoning table. The actual proposed side yard setback, proposed height, and proposed percent green space should be included in the zoning information table on sheet C201 in order to confirm compliance.
3. If any lighting or landscaping is proposed at the site, these should be shown on the site plan. The Planning Board should determine if any additional screening is necessary.

Planning

1. Sheets C 101 and C 102 should be provided as a single map in order to more clearly convey overall site conditions. Topography of the remainder of the site outside of the leased area would be helpful in understanding the relationship of the site to surrounding environmental resources. These can be shown as approximate using GIS or similar data set.
2. Proposed inverter or transformer pads should be shown.
3. Clarification is needed regarding the material or vegetation proposed to be located beneath the panels. Natural vegetation incorporating a pollinator friendly mix is encouraged. We can provide recommendations, if necessary.
4. Areas of slopes of 15 percent or greater and areas of exposed bedrock should be shown on the site plan. If panels are proposed to be installed in bedrock areas, a description of the installation process should be provided as well.
5. Wildlife friendly fencing should be specified with a 6 -12 inch gap along the bottom to allow animals to pass through the site.
6. Emergency Response. An operations and maintenance narrative should be provided discussing the responsibilities for maintaining and inspecting panels, access and responsibility during emergency situations. The Fire Department should be consulted on this matter.

SEQR/Coordination

1. Classification. The Town Board determined that this project constitutes a Type I SEQR Action, and circulated a Notice of Intent to serve as Lead Agency in a coordinated review on December 19, 2024.
2. We have provided a draft Full Environmental Assessment Form Part II for the Town Board's consideration, attached to this memorandum. The Town Board should review and decide if it agrees with the potential impacts identified as "moderate or large." Once the Town Board is satisfied and adopts the Part II form, the applicant should prepare a Part III submittal, addressing each of the impacts noted by as potentially moderate or large in scale. The potential impacts that we have identified are:

- **1. Impacts on Land**

- 1.b- The proposed action may involve construction on slopes of 15% or greater.
- 1.c- The proposed action may involve construction on land where bedrock is exposed, or generally within 5 feet of existing ground surface.
- 1.f- The proposed action may result in increased erosion, whether from physical disturbance or vegetation removal (including from treatment by herbicides).

We note that per the FEAF Part 1, approximately 52 percent of the site contains bedrock outcroppings, and approximately 52 percent of the site contains slopes of 15 percent or greater.

- **3. Impacts on Surface Water**

- 3.d- The proposed action may involve construction within or adjoining a freshwater or tidal wetland, or in the bed or banks of any other water body.
- 3.h- The proposed action may cause soil erosion, or otherwise create a source of stormwater discharge that may lead to siltation or other degradation of receiving water bodies.

As previously noted, there are considerable areas of steep slopes and bedrock outcroppings throughout the site. These factors, in combination with the proposed tree clearing of approximately 24 acres may lead to an increase in erosion and stormwater runoff compared to sites with less varied topography. The potential impacts to the wetland areas at and surrounding the project site, should be considered.

- **5. Impacts on Flooding**

- 5.d- The proposed action may result in, or require, modification of existing drainage patterns.

Extensive grading is proposed at the site. As noted above, a SWPPP has not yet been received.

- **7. Impacts on Plants and Animals**

- 7.a- The proposed action may cause reduction in population or loss of individuals of any threatened or endangered species, as listed by New York State or the Federal government, that use the site, or are found on, over, or near the site.
- 7.b- The proposed action may result in a reduction or degradation of any habitat used by any rare, threatened or endangered species, as listed by New York State or the federal government.

- 7.g- The proposed action may substantially interfere with nesting/breeding, foraging, or over-wintering habitat for the predominant species that occupy or use the project site.
- 7.h- The proposed action requires the conversion of more than 10 acres of forest, grassland or any other regionally or locally important habitat.

We note that the following species have been identified as potentially present at the site: Indiana Bat (endangered), Northern Long-eared Bat (endangered), Tricolored Bat (proposed to be endangered), Monarch Butterfly (candidate). Additionally, approximately 24 acres of wooded area is proposed to be cleared.

- **9. Impact on Aesthetic Resources**

- 9.a- Proposed action may be visible from any officially designated federal, state, or local scenic or aesthetic resource.
- 9.c- The proposed action may be visible from publicly accessible vantage points.
- 9.d- The situation or activity in which viewers are engaged while viewing the proposed action is routine travel by residents, including travel to and from work.
- 9.f- There are similar projects visible within 3 miles of the proposed project.

We note that this site is located within 5 miles of many parks and recreation uses, as well as approximately 1.4 miles from the Hudson River and the Estates District Statewide Area of Scenic Significance. While the applicant has provided photo simulations of the site, additional analysis will be needed in order to determine potential visual impacts. Our review pertaining to the photo simulations provided will be issued at a later date. The Board may wish to discuss whether there are specific viewpoints that should be included in this analysis. It appears that there are solar arrays located on Hallihan Hill Drive, which is approximately 2 miles from the project site, and Frank Scottile Boulevard, approximately 1 mile from the project site.

- **10. Impact on Historic and Archeological Resources**

- 10.b- The proposed action may occur wholly or partially within, or substantially contiguous to, an area designated as sensitive for archaeological sites on the NY State Historic Preservation Office (SHPO) archaeological site inventory.

Per correspondence from OPRHP, and the Phase 1 A and B reports undertaken by the applicant, Precontact Locus 1, Precontact Locus 2 and Precontact Locus 3/Frank Sottile Precontact Site (USN 11118.000045) are located at the site.

- **17. Consistency with Community Plans**

- 17.a- The proposed action's land use components may be different from, or in sharp contrast to, current surrounding land use pattern(s).

We note that while commercial uses are located along Route 9W, the uses directly adjacent to the project site are largely undeveloped or residential in nature.

- **18. Consistency with Community Character**

- 18.e- The proposed action is inconsistent with the predominant architectural scale and character.
- 18.f- Proposed action is inconsistent with the character of the existing natural landscape.

As noted previously, there is significant grading and tree clearing proposed at the site in order to accommodate the proposed solar arrays.

3. County/GML Review. The Town Board referred this application to the Ulster County Planning Board on December 19, 2025. A letter of recommendation was received from the Ulster County Planning Board dated January 8, 2025, which the applicant has responded to in a letter dated February 5, 2025.
4. NYS DEC Article 24 Procedure. As of January 1, 2025, the NYS DEC has amended Article 24 of the Freshwater Wetlands Act, expanding its jurisdiction. The Environmental Resource Mapper suggests that there may be jurisdictional wetland areas at the front of the property, near and west of the proposed access road. The applicant has submitted a Parcel Jurisdictional Request to the NYS DEC.
5. A Phase IA Literature Review and Archeological Sensitivity Assessment and a Phase 1B Archeological Field Reconnaissance Survey were conducted by the applicant and submitted to OPRHP. It was determined that there are three Loci associated with a Precontact Indigenous site within the Area of Potential Effects. OPRHP reviewed these reports and issued a letter dated March 13, 2025, stating that there are no anticipated impacts to properties, including archaeological and/or historic resources, listed in or eligible for the New York State and National Registers of Historic Places, **with the condition that the Site Avoidance Plan is implemented. We recommend that this area be clearly marked on the site plan.**
6. This application should be circulated to the fire department for comment, if it has not been already.
