Supervisor: 2010, Environmental Impact Statement was prepared by then-owner of Tech City campus; proposed redevelopment plan. Suggestions made to create overlay district, triggered by request of future developer to streamline uses at the site. Original overlay had restrictions by facts presented at that time by DEC and through public comment. Biggest issue related to:

1. Construction and use of residential units on the first floor of multi-story buildings, stating first floor be reserved for commercial use; 2. Mix of units within a building (two bedroom, no less than 850 sq. ft. and one bedroom no less than 700 sq. ft.); 3. Number of stories in a building. Project is in zoning district OM, heights have been 75 feet, not being modified. Original proposals for project consisted of three story buildings. Presently, developer would like two, five story buildings.

Zoning proposal which removes restriction on resident uses; revises residential use permits to include studio, one bedroom, and two bedroom units; adding a new subsection allowing five story buildings or 75 feet, whatever is less. Purpose of this legislation is for a zoning change. Does not mean that the project is approved, as they still have to proceed through town and county planning board approvals.

# RESOLUTION TOWN OF ULSTER BOARD COURT CLERK STAFF ASSIGNMENTS OCTOBER 5TH 2023

WHEREAS, it has been the intention of the Town of Ulster to maintain a Municipal Court

WHEREAS, it is the responsibility of the Town of Ulster Board to hire and maintain staffing to support the Court.

WHEREAS, all court clerks are employees of the Town of Ulster.

WHEREAS, on repeated occasions over the past year the Personnel Committee has been requested by Hon. Kelly Flood-Myers and Hon. Susan Kesick to intervene in court staffing and personnel issues.

WHEREAS, the Personnel Committee participated in a meeting with both Judges and David Dellehunt from NYSOCA as a mediator and consultant to discuss potential solutions.

WHEREAS, with the Personnel Committee's assistance the option is to allow the Judges to work out arrangements that were mutually agreeable were unsuccessful and it is clear after these meetings that there is no agreement between the two Judges.

WHEREAS, the current management structure has the Judges sharing joint responsibility and direction of the court staff.

WHEREAS, the operational management of the Town of Ulster Court is at an impasse and is dysfunctional.

WHEREAS, other municipalities within New York State have resolved this similar problem by dividing the management and direction of the court staff between the Judges individually. NOW THEREFORE BE IT RESOLVED, the Ulster Town Board directs that the current court staff be individually assigned to and report to the two Judges as follows:

Hon. Kelly Flood-Myers' court clerk staff will include Rosanne Kaznowski as full-time personal Clerk, Valarie Craig as full-time Court Clerk, and Jasmine Otero-Burt as part-time Court Clerk.

Hon. Susan Kesick's court clerk staff will include Karen Gorski as full-time personal Clerk, Taylor Crespino as full-time Court Clerk, and Judy Horvers as part-time Court Clerk.

NOW THEREFORE BE IT RESOLVED, the job descriptions and duties of the Court Clerk staff will remain the same as they have been prior to this resolution.

NOW THEREFORE BE IT RESOLVED, any future replacement or additions to the Court Clerk staff will be assigned specifically and individually to an individual Judge as required and agreed to by the Board.

RESOLVED that this resolution will be in effect immediately upon approval by the Board.

Re: Town of Ulster Tentative 2024 Budget

Good evening, Supervisor Quigley and Members of the Town Board:

On behalf of the TownOfUlsterCitizens.org, I wish to offer the following comments on of the town's 2024 tentative budget. Our first two points simply state the obvious:

- 1. Resoundingly and predictably, we liked last year's final budget reduction in taxes more than this phase of the 2024 budget which leans into a tax increase of about 3%. We hope that last year's hard budgetary work will serve as a similar good example for the 2024 final version
- 2. We would enjoy meeting Town Council Member, Maryanne DeGroodt, who, according to pages 92 and 109 of the budget preparation materials, is assuming board member status for the departing Eric Kitchen. Some of us were not paying attention to that baton hand-off.
- 3. Because the unadorned details of the 132 generous pages of the tentative budget read less like a budget and more like a general ledger on an iron-man swim, we recommend that the next iteration of the 2024 budget use the pie charts and bar graphs similar to those used on pages 11 and 12 of the 2022 audited financial statements. We recommend comparisons of 2023 close-out assumptions juxtaposed with 2024 budget assumptions. A pictorial version is very helpful to citizens understanding this process a little better. We all acknowledge that the 4<sup>th</sup> quarter of 2023 hasn't happened and the factual numbers will not be compiled until the first quarter of 2024, which makes 2023 revenues and expenses an educated guess.
- 4. The rest of our comments are our guesses based on new understandings of our town's fiscal position and past performance.
  - a. New understanding
    - i. Taxable values are <u>down by nearly 1 ½ percent</u>. It must be that businesses are the issue here because residential values are increasing. The overall loss of value is about \$14M is probably due to tax certiorari judgments against the town. Empty stores bring down tax assessment values.
    - ii. A portion of the surplus money left over from last year and accumulated from previous years, is known as fund balance. There are different kinds of fund balance accounts to which surplus is assigned. A portion of the fund balance

\* - -

is put aside for needs that always pop up. True to its name, the unassigned fund balance is the most fungible, interchangeable commodities that our Town has. No strings attached, it can be used for anything the Town Board sees fit at any given time such as certain capital expenses. The remaining unassigned fund balance at the end of this year is projected to be a very healthy \$3.3M, after reassigning \$1.2M from that account to meet needs at hand.

- iii. The 2024 Budget appropriation is <u>up about 1½ percent</u>, seeking to close a gap of about \$815,000. A fiscal layman might observe that such a gap could easily be closed by a small portion of the \$3.3M.
- iv. The **business tax base is not growing as fast as expected**. For example, iPark 87 recently suffered a setback from one of its potential anchor businesses, Zinc8.

#### b. Past Performance

- i. The Town of Ulster has earned a positive reputation for its fiscal acumen and robust fiscal health. This just does not happen all by itself. It is due to prudent management and generous taxpayers. For both reasons, the past is prologue.
- ii. Over the past 7 years, EFPR, our independent auditors noted a steady growth in the accumulated unassigned fund balances (rounded):
  - 1. At the end of **2022**, it was **\$4.5M** which was **46**% of the General Fund expenditures.
  - 2. At the end of **2021**, **it was \$3.6M which was 42%** of the General Fund expenditures.
  - 3. At the end of **2020**, it **was \$3.2 M which was 41%** of the General Fund expenditures.
  - 4. At the end of **2019**, it was **\$2.7 M which was 33%** of the General Fund expenditures.
  - 5. At the end of **2018**, it was **\$1.8 M which was 23%** of the General Fund expenditures.
  - 6. At the end of **2017**, it was **\$1.9 M which was 25%** of the General Fund expenditures.
  - 7. At the end of **2016**, it was **\$2.0 M which was 26%** of the General Fund expenditures.
- iii. There are several short-hand ways to gauge the fiscal health of any municipality at the end of a fiscal year. One of them is called "current ratio," the ratio of current assts to current liabilities. This ratio answers the question of how well can a municipality meet its current bills. The current ratio is determined by dividing current assets (cash and cash equivalents) by current liabilities (current bills).
  - 1. A ratio of 1-to-1 indicates a break-even between assets and liabilities.
  - 2. A ratio of 2-to-1 indicates twice the cash needed to meet its current bills
  - 3. The Town of Ulster's current ratio at the end of 2023 was 10.6-to-1 which is almost 11 times break-even.
- 5. In summary, citizens are grateful that the Town Board "shows all of its cards."
  - a. We are asking the Town Board to make a decision not to tax homeowners just to replenish our already high fund balance structure.
  - b. We are asking the Town Board to close the identified gap of \$815,000 with some of our unassigned fund balance.
