Good evening, Supervisor Quigley and Members of the Town Board.

On behalf of the TownOfUlsterCitizens.org, I wish to offer the following preliminary comments on the effects of a publicized proposal of an upscale housing and golf course development that includes 520 acres in Woodstock that are intended to be joined with an adjacent 106 acres in the Town of Ulster. We viewed a recording of the hour-long July 20th Woodstock Planning Board meeting with the principal developers of Woodstock National who presented their first draft plans as a prelude to a formal application.

Judging from the gracious yet pointed remarks from the Woodstock officials, we think that the developer will have some heavy lifting to do to demonstrate project feasibility against town standards and expectations. We note the following points made by Woodstock Planning Board:

- Zena Woods, the area in question, is designated as a "critical environmental area" because of its ecological sensitivity of forest and wetlands.
- The 90 unattached residences in the concept plan are on 1 to 4 acres. New residential development in Woodstock requires at least 5 acres.
- When the concept plan becomes an application, the Planning Board would like to see
 evidence that all applicable Woodstock zoning codes and wetlands preservation
 requirements are being adhered to. Some of Woodstock's regulations are more stringent
 than those of NYSDEC.
- The affordable housing area of 12-20 units appears be separate from all other housing, and it is located just below the central sewer treatment plant for the site. Both appear near the Sawkill Creek. An application will need a full discussion on personal and environmental health and safety issues related to these placements.
- The FAA certified small-plane landing strip in the upper-most part of the map would be used mostly as a golf practice range and occasionally a helipad. More information will be needed.

In the current plan, the 106 acres in the Town of Ulster would remain landlocked with ingress and egress only through Woodstock. This parcel is slated to accommodate 3½ to 4 golf holes out of the 18 holes and a cluster of 77 townhomes in the northeast corner of the parcel (39.1-1-21.100). The county's parcel viewer indicates steep slopes and a stream where the golf holes are planned. We cannot imagine how that terrain will not be compromised in the shaping of the golf holes, their maintenance, and the wear and tear by golfers and golf carts. The golf course

planner claims to have a strong focus on conservation with the golf course being a non-chemicalized sustainer of the natural environment. That seems to us more aspirational than practical. Conservation denotes preservation and protection, but it should not connote exploitation and change of purpose.

Our initial opinions of this project in the Town of Ulster disfavor the concept plan as publicized:

- The Town of Ulster parcel, known as Ruby Woods, is landlocked. There are no roads directly connected to the Town of Ulster for emergency or highway department access. Road access to this site from our town may not be possible.
- The Town of Ulster does not need another golf course and certainly not one that is exclusive. Within 20 miles of the Town of Ulster there are already 20 serviceable golf courses. Two of them, Wiltwyck Golf Club in the Town of Ulster and the Woodstock Golf Club, are near the proposed site and would welcome new members. Wiltwyck, once a members-only club for people in our area, has for several years welcomed public play because they cannot recruit enough members to achieve economic viability.
- We do not need high-end housing but rather more affordable housing like many of the 800 units planned by iPark87.
- We do not need more clear-cutting of trees planned for these 106 acres of Ruby Woods, a parcel which borders a conserved forest that is overseen by the Woodstock Land Conservancy.
- Plans for residential water include only private wells which may or may not be adequate for 77 townhomes and may or may not compromise wetlands. The same is true of water required the golf course.

We do not expect the Town of Ulster Planning Board or the Town Board itself to take these comments under consideration until and unless an application is formally delivered by the developer. Nevertheless, the intent of the Woodstock National developer is out in the public domain, and these comments from the TownOfUlsterCitizens.org pertain only to that intent. If the formal application of Woodstock National resembles the intent they have already floated, we are available to learn about any changes and offer public comment as appropriate.
