- Automotive products: used oil, used oil filters, carburetor cleaner, etc.
- Refrigerators, Air conditioners and Dehumidifiers (Unless Freon has been removed).

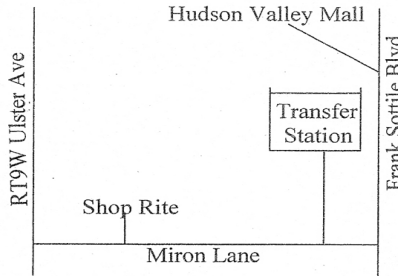

Permits and Fees

Town of Ulster Residents:

- \$75 per year
 - \$60 second permit (yearly only)
 - \$55 half year (After July 1st)
 - \$22.50 single day
- Senior Rates-62 Years (Proof of Age Required):
- \$55 per year
 - \$45 second permit (yearly only)
 - \$45 half year (After July 1st)
 - \$15 single day

Punch Cards:

1 Punch=\$4.50

(Available in 5, 10 and 20 punches)

Non-Residents:

(Permits available at Town Clerk's Office Only)

- \$100 per year
- \$75 second permit (yearly only)
- \$80 half year (After July 1st)
- \$25 single day

Punch Cards:

1 Punch=\$6.00

(Available in 5, 10 and 20 punches)

Landscapers:

(Permits Available at Town Clerk's Office Only)

- \$100 Annually
- Leaves & Grass Clippings-Free
- Brush-\$25 per load

Items Available to Permitted Users Only

Wood Chips -Free

Screened Mulch-

- 30 gallon can - (1) punch*
- Pick up truck load - (5) punches*
- 1-ton dump truck or trailer - (10) punches*
