

**Annual Drinking Water Quality Report for 2022**  
**Town of Ulster Water District**  
**1 Town Hall Drive – Lake Katrine, New York 12449**

**INTRODUCTION**

To comply with State and Federal regulations, the Town of Ulster Water District will be annually issuing a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and your awareness of the need to protect our drinking water sources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system has never violated a maximum contaminant level. This report provides an overview of last year’s water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

**WHERE DOES OUR WATER COME FROM?**

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations, which limit the amount of certain contaminants in water provided by public water systems. The State Health Department and the FDA’s regulations establish limits for contaminants in bottled water as well, which must provide the same protection for public health.

Our water source is drawn from three wells, which are located on Fording Place Road and Parish Lane in Lake Katrine. The water is pumped from the wells to the treatment plant where it is softened and chlorine and potassium permanganate are added to enhance the iron removal process as it passes through the Ferrosand “cr” filters. The water is disinfected again with chlorine as it leaves the plant. During 2022, our system did not experience any restrictions of our water source.

Through an agreement with the City of Kingston’s Board of Water Commissioners, the Ulster Water District purchased a total of 700,000 gallons of water per day from the Kingston Water Department. Some of this water is blended with water pumped from our Ulster Water plant on Fording Place Road and is part of the total gallons produced by the Ulster Water District listed below under facts and figures. **FACTS AND FIGURES**

Our water system serves 5500 customers through 1690 service connections. The total water produced by the Ulster Water District in calendar year 2022 was 306,601,291 gallons. The daily average of water treated and pumped into the distribution system was 840,004 gallons. The highest single day total was 1,495,500 gallons on May 14th. The total amount the Ulster Water Department purchased from the City of Kingston’s Water Department in 2022 was 151,198,591 gallons or an average of 414,243 gallons per day. The amount of water consumed by metered customers was 259,092,248 gallons. In 2022 there was an unaccounted for water loss total of approximately 12%. Unaccountable water loss can be attributed to various sources, including but not limited to, water distribution leaks, street sweeping, firefighting and training. In 2022, water rates were as follows: 1<sup>st</sup> 5000 gallons or any portion thereof \$27.50 Over 5,000 gallons and up to 200,000 gallons = \$3.65 / thousand. Over 200,000 gallons = \$4.60 / thousand.

**ARE THERE CONTAMINANTS IN OUR DRINKING WATER?**

As the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include: total coliform, turbidity, inorganic compounds, nitrate, nitrite, lead and copper, volatile organic compounds, total trihalomethanes, haloacetic acids, radiological and synthetic organic compounds. The table presented below depicts compounds detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old.

**Notes:**

- 1-The level represents the 90<sup>th</sup> percentile of the 20 sites tested. The action level for lead was not exceeded at any of the sites tested.
- 2-The level presented represents the 90<sup>th</sup> percentile of the 20 sites tested. A percentile is a value on a scale of 100 that indicates the percent of a distribution that is equal to or below it. The 90<sup>th</sup> percentile is equal to or greater than 90% of the copper values detected at our water system. Out of the 20 samples that were collected the 90<sup>th</sup> percentile value was .41mg/l. The action level for copper was exceeded at one of the 20 sample sites.
- 3- Water containing more than 20 mg/l of sodium should not be used for drinking by people on severely restricted sodium diets. Water containing more than 270 mg/l of sodium should not be used for drinking by people on moderately restricted sodium diets.
- 4- This level represents the highest locational running annual average calculated from data collected.
- 5- Turbidity is a measure of the cloudiness of the water. We monitor it because it is a good indicator of water quality. High turbidity can hinder the effectiveness of disinfectants. Out of the 157 turbidity samples taken in the Town of Ulster in 2022, and the average was .27. State regulations require that 95% of turbidity samples collected have measurements below 0.3 NTU and that all turbidity results are <1 NTU. There were no turbidity results above .29 taken during the year 2022.

**Definitions:**

**Maximum Contaminant Level (MCL):** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.

**Maximum Contaminant Level Goal (MCLG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Action Level (AL):** The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

**Milligrams per liter (mg/l):** Corresponds to one part of liquid in one million parts of liquid (parts per million - ppm).

**Micrograms per liter (ug/l):** Corresponds to one part of liquid in one billion parts of liquid (parts per billion - ppb).

**Maximum Residual Disinfectant Level (MRDL):** The highest level of drinking water disinfection allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**Maximum Residual Disinfectant Level Goal (MRDLG):** The level of a drinking water disinfectant below which there is no known or expected health risk. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**Treatment Technique (TT):** A required process intended to reduce the level of a contaminant in drinking water.

**Nephelometric Turbidity Unit (NTU):** A measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

It should be noted that all drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. **What Does This Information Mean?**

As you can see by the table, our system had no violations. We have learned through our testing that some contaminants have been detected; however, these contaminants were detected below the level allowed by the State.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants, and young children. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. The Ulster Water District is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. **Is Our Water System Meeting Other Rules That Govern Operations?**

During 2022 our system was in compliance with all applicable State drinking water operating and reporting requirements.

**Do I Need To Take Special Precautions?**

Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. **Why Save Water and How Do We Avoid Wasting It?**

Although our area is very fortunate to have access to a water supply which more than meets our demands, conservation efforts by both the town and the consumer are prudent in deterring increasing costs. As a consumer you can participate in this water conservation effort. The following are some ideas that can be directly applied to your individual homes: 1) Use water-saving, flow-restricting shower heads and low flow faucets (aerators); 2) Repair dripping faucets and toilets that seem to flush by themselves; 3) Replace your toilet with a low flush model or place a brick in your tank to reduce the volume used on each flush; 4) Water your garden and lawn only when necessary. Remember that a layer of mulch in the flower beds and garden is not only aesthetically pleasing but will help retain moisture; 5) Water your lawn after 6:00pm, as this prevents water loss due to evaporation; 6) When washing your car don't let the hose run continuously; and 7) When brushing your teeth, or when shaving or shampooing your hair try to avoid running the water unnecessarily; and lastly try whenever possible to wash clothes and run the dishwasher only when you have a full load.

**Source Water Assessment:**

The New York State Department of Health has completed a source water assessment for Well #2 and Well #3 of this system, based on available information. Possible and actual threats to these drinking water sources were evaluated. The state source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how easily contaminants can move through the subsurface to the wells. The susceptibility rating is an estimate of the potential for contamination of source water. It **does not** mean the water delivered to consumers is, or will become contaminated. The source water assessments provide resource managers with additional information for protecting source waters in the future. The source water assessment has rated these wells as having a high susceptibility to microbials, nitrates, industrial solvents and other industrial contaminants. These ratings are due primarily to the close proximity of permitted discharge facility (industrial/commercial facilities that discharge wastewater into the environment and are regulated by the state and/or federal government); a hazardous waste facility; a toxic chemical release facility; and low intensity residential activities in the assessment area. In addition, the wells draw from an unconfined aquifer and the overlying soils do not provide adequate protection from potential contamination. Please note that, while the source water assessment rates our wells as being susceptible to microbials, our water is disinfected to ensure that the finished water delivered to your home meets the New York State drinking water standards for microbial contamination.

Made 14 Repairs to the Water main due to Water Breaks during the year 2022.

04/2022 – Installed Chlorine analyzer at the Dogwood Street Pump Station

06/2022 – Replaced Fire Hydrant on Leggs Mills Road.

This water system has increased preventive security measures to protect the water supply from vandalism. The public can also assist us by reporting any suspicious activities around water department facilities or properties.
